#### **David Henderson, Ed.D. – Montana State University – Bozeman**

Dr. Henderson grew up in Memphis, Tennessee, and was a high school chemistry and biology teacher and coach after completing a B.A. in science education at Harding University where he later completed an M.Ed. in English education. After working in the software field, he moved to Yaak, Montana in 1993 where he taught grades 5-8 in the last one-room school in Montana that still met in its original log cabin. Since then, Dr. Henderson earned his doctorate, worked as a public school educator, coach, and high school principal, taught as an adjunct at The University of Montana in Missoula, and co-founded Montana Courage to Teach. He currently teaches Educational Leadership at Montana State University in Bozeman.

He also co-founded Mariah’s Challenge and currently serves as the board President.

#### ***Changing Traffic Safety Culture***

Safety culture aims to prevent crashes, reduce errors, and change behavior. Drivers caught speeding, driving impaired, and/or disregarding the rules of the road need both education and consequence. Municipal judges can influence drivers who have made critical driving errors. Judge Kilmer and Judge McCarthy will share some of their educational as well as enforcement approaches to improving drivers’ behavior.

**Judge Jerome McCarthy** spent 26 years with the Butte-Silver Bow Law Enforcement Agency, working as a detention officer, police officer and detective before retiring this past January as a captain. He has since been a criminal investigator for the Montana Office of Public Defender.

**Stacy Aaberg** is in her eleventh year of teaching at Conrad High School. She began teaching driver education the summer of 2013 after Jim Carroll, her Driver Education teacher, convinced her that she would be a great asset to the Conrad program. Stacy was born and raised in Conrad and graduated from Conrad High School in 2001. She went on to attend Montana State University where she obtained a Bachelor's in Health Enhancement with an endorsement in Special Education. In the Fall of 2013 she began working on her Family Consumer Science Minor and taught FCS while advising the FCCLA.

**Jeff Mead** semi-retired from teaching in 2014 after a long career as athletic director and driver education instructor in eastern Montana. He is a past president of MTEA and has served on the MTEA Executive Board. He currently teaches driver education in Fairview, Savage and Sidney, has taught for Montana DRIVE since 2007, and promotes bicycle safety and code compliance in Sidney, MT.

**Taylor Lonsdale, P.E.** is a member of the Small Urban, Rural, and Tribal Center on Mobility at the Western Transportation Institute of Montana State University. Taylor's work focuses on bicycle and pedestrian safety. Taylor served as the Safe Routes to School (SRTS) Coordinator for Montana from 2009-2013, working with more than 50 communities across Montana to support SRTS program development. Taylor is a certified traffic cycling instructor with both the American Bicycling Education Association and the League of American Bicyclists. Taylor has a bachelor's degree in civil engineering with more than 18 years of civil engineering design experience.

**Chris Brown** is a Licensed Athletic Trainer employed by St. James Healthcare, working in their Montana Sports Medicine department. He has been board certified since graduating from George Fox University in 2010. Chris provides outreach Athletic Training services to Twin Bridges Schools, covering all sporting events. Chris is a Montana native who graduated from Plains High School in 2006.

**Roger and Sharon DiBrito** live between Lolo and Florence and have long promoted sustainable transportation and safe journeys on two-wheeled vehicles. They came to Missoula in 1976 as elementary and preschool teachers. After Roger retired as a health enhancement teacher, he and Sharon began teaching children and adults how to mix with traffic as pedestrians, bicyclists, and motorists. In 2015, Roger was named the 2015 Parks and Trails Steward by the Missoula County Parks and Trails Advisory Board.

Motorcycles need space, they are smaller and can create an improper illusion as to where they are exactly located, and that they maneuver quickly out of the cone of vision provided by the car's mirrors, necessitating an increased awareness of the car driver's surroundings.

E-cigarettes are now the number one tobacco product used by Montana youth and it makes perfect sense that those involved with any student education program become well informed about these ever-changing products. Prior to her work with the OPI, Kris worked as a community organizer to prevent underage drinking and previous to that she taught health and physical education in rural Alaska.
