
Driver Education Arrives in Montana 1950

1965- MT Law allows 15 year old drivers to license after passing approved TE course approved by MT Highway Patrol and Office of Public instruction






- 1970- Name change to Montana Traffic Education Association

- 1975- TE minor at MSU and NMC endorsed





- 1979- Advanced Driver Education Program begins in Lewistown- Name later changed to Montana DR.I.V.E.








- 1980- MTEA logo contest

- 1983- membership at 147
- 1985- first 3-day, 2 credit workshop/conference; Parent involvement promoted; Legislative committee formed (Dan Purcell, Helena)



- 1986- Member Recognition Program initiated
- 1987- Constitution revision committee established
- 1988- MTEA's first TOY (Ken Watson, Rudyard) and SOY (George Fultz, Fort Benton)

- 1993- Executive Board expanded to model ADTSEA for more input by members

1995- Cuts to TE reimbursement by State Legislature! Legislature (with DOJ) approves CDTP - piloted by Helena Schools

1996- MTEA Newsletter initiated




TOP 10 STATES WITH THE WORST DRIVERS

- 2001-2002- ARM 10.13.307 1 and MCA 61-5-106 rules pertaining to open enrollment in TE to ALL students residing within school's jurisdiction
- 2002-2004- TE student contact days increased from 20 to 25 to extend learning





- 2005- Montana Legislature GDL in Montana!
- 2006- GDL goes into effect in Montana
- 2006 OPI releases new curriculum modules and resources (Beth Shepard)
- 2009- AD&D/Life policy (5K) offered to MTEA members

- Techniques for guiding teen driver's practice period
- · Log to track practice time
- · Parent/Teen contract
- Bring to driver examiner when applying for restricted license; they will ask for it.

Driver Education Parents/Guardians Meeting

- · Course schedule
- Requirements
- Expectations of the teen student and the parents/ guardians
- + Montana Graduated Driver Licensing (GDL) law
 - Requires 50 hours of supervised practice driving including 10 hours at night, with an adult
 - Teens need 2 hours of driving practice each week to meet the required 50 hours within 6 months – Learner licenses are valid for one year
 - · Limits passengers and restricts night driving with first year license



- 2010- David Huff retires from OPI TE Director
- 2011- Fran-Penner-Ray becomes permanent TE Director
- 2012- Content and Performance Standards developed and refined on TE curriculum project
- 2014- OPI revises Teen Driver Curriculum with new research data and media resources (committee headed by Rich Hanson)
